RESOLUTION NO. 982-2024

DECLARING SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2024 OF BAUTISTA, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P4,775,886.46, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2024 involving total appropriations of Php4,775,886.46 which was enacted on August 5, 2024 through Appropriation Ordinance No. 2, S. 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the implementation of the First Tranche Salary Adjustment to all municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 160 dated August 12, 2024 specifically Item 5.0 thereof;
2. That the reversion of Personal Services Savings shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

3. That all procurement to be undertaken shall be subject to the pertinent provisions of R.A No. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules & Regulations;
4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007; and
5. That the appropriation for Monetization of Leave Credits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 Re: Computation & Funding of Terminal Leave Benefits & Monetization of Leave Credits, which provides for the new constant factor stated under 3.1 thereof.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


