RESOLUTION NO. 983-2024

APPROVING RESOLUTION NO. 2024-122 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF LAOAC, PANGASINAN IN THE TOTAL AMOUNT OF TWENTY-NINE MILLION THREE HUNDRED SEVENTY THOUSAND SEVEN HUNDRED EIGHTY-TWO PESOS & 66/100 (P29,370,782.66)”

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 2024-122 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Laoac, Pangasinan has identified items in their 3rd Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan for approval on July 24, 2024 by the Municipal Development Council through Resolution No. 2024-03;
2. The SAIP covers fund augmentation for the Personal Services (granting of increase in RATA), Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, and the implementation of various development programs/projects of the LGU. It also includes the programs/projects to be funded out of the Excise Tax CYs 2017 and 2019;

3. The identified programs/projects under the Excise Tax are based on Local Budget Memorandum No. 81 dated November 4, 2020 and Local Budget Memorandum No. 84 dated November 22, 2021;
4. The proposed programs/projects to be funded by the 20% Development Fund are based on DBM-DOF-DILG Joint Memorandum Circular No.1 dated November 4, 2020 “Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects”; and
5. Funding support for the full implementation of the same in the amount of PhP29,370,782.66 is embodied in their proposed Supplemental Budget No. 3 for CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-003 on August 19, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Laoac, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


