RESOLUTION NO. 984-2024

DECLARING SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2024 OF LAOAC, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P29,370,782.66, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2024 involving total appropriations of Php29,370,782.66 which was enacted on August 19, 2024 through Appropriation Ordinance No. 2024-003;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the grant of increase in Representation and Transportation Allowances (RATA) shall be in accordance to the provisions of Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management;
2. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;

3. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);
4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 Series of 2017 dated March 8, 2007;
5. That the utilization of appropriations from 20% Development Fund shall be in accordance with the provisions of DBM - DOF - DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re "Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects"; and
6. That the utilization of appropriations from FY 2017 and FY 2019 shares of the Municipality from the Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum No. 81 dated November 4, 2020 and Local Budget Memorandum No. 84 dated November 22, 2021.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 3 for Calendar Year 2024 of Laoac, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Laoac Pangasinan, for its information and guidance.
