APPROVING MUNICIPAL RESOLUTION NO. 79-2024 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 01 FOR CY 2024 OF THE MUNICIPALITY OF NATIVIDAD, PANGASINAN AMOUNTING TO NINETEEN MILLION SIX HUNDRED FORTY FIVE THOUSAND SIX HUNDRED NINETY PESOS AND SIXTY CENTAVOS (P19,645,690.60)”

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Municipal Resolution No. 79-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council Executive Committee of Natividad, Pangasinan has identified items in their Supplemental Annual Investment Program No. 02 for CY 2024. This was endorsed to the Sangguniang Bayan on June 5, 2024 through MDC Executive Committee Resolution No. 02-2024;

2. The SAIP No. 02 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses (MOOE) and Capital Outlay of various offices in the LGU and the implementation of development projects and disaster risk reduction programs of LGU Natividad;
3. Funding support for the proposed SAIP No.02, with a total investment requirement of PHP19,645,690.60 is embodied in the municipality's Supplemental Budget No. 01-2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01-2024 on July 15, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Natividad, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


