APPROVING MUNICIPAL RESOLUTION NO. 252, S-2024 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Resolution No. 252, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Local Development Council revised their AIP 2024 to include the new projects and endorsed the same to the Sangguniang Bayan for approval on July 10, 2024 through MDC Res. No. 03, Series of 2024. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. The previously approved AIP 2024 of the LGU was revised to include the disaster risk reduction programs/ projects /activities to be funded from the prepared Supplemental LDRRM Plan CY 2024 to utilize the unexpended balances from LDRRMF CYs 2020 to 2023 in the amount of PhP14,888,000.00. This has emanated from the Municipal Disaster Risk Reduction and Management Council and approved through MDRRMC Res. No. 10, Series of 2024; and

3. The preparation of the Revised AIP is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote: 6.5. The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Nicolas, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


