**PROVINCIAL RESOLUTION NO. 1022-2024**

**AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A CONTRACT AGREEMENT WITH GMA NETWORK, INC. CHANNEL 10 DAGUPAN RELATIVE TO THE TELEVISION/RADIO BROADCASTING FACILITIES FOR THE PANGASINAN CAPITOL PASKUHAN ON DECEMBER 14, 2024**

**WHEREAS**, the Provincial Government of Pangasinan will be celebrating the 2024 Pangasinan Capitol Paskuhan with the theme, "*Paskong Ang Galing, Bida Mga Chikiting*";

**WHEREAS**, GMA Network, Inc. was incorporated in June 14, 1950 as a free-to-air broadcasting company principally engaged in television and radio broadcasting, the production of programs for domestic and international audiences, and other related businesses;

**WHEREAS**, for this year's Pangasinan Capitol Paskuhan celebration, GMA Network, Inc. shall be the strategic partner of the Provincial Government of Pangasinan in the conduct of the Kapuso Fiesta which will feature Kapuso artists on December 14, 2024;

**WHEREAS**, this partnership between the Province of Pangasinan and GMA Network, Inc. would ultimately spread the spirit of Christmas to children and families, promote community engagement, highlight Filipino media and entertainment, provide a family-friendly cultural experience, and support local businesses;

**WHEREAS**, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (b) (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

**NOW THEREFORE**, on motion of SP Member Marinor B. de Guzman, duly seconded, it was –


