### PROVINCIAL RESOLUTION NO. 1026-2024

**AUTHORIZING THE USE OF THE TRUST FUND OF THE PROVINCIAL GOVERNMENT OF PANGASINAN FOR THE OPERATIONALIZATION OF THE PROVINCE-LED AGRICULTURE AND FISHERY EXTENSION SYSTEM (PAFES) AND IMPLEMENTATION OF PROJECTS AND ACTIVITIES FOR FY 2024 IN SUPPORT TO THE PANGASINAN CORPORATE FARMING PROJECT FOR RICE**

**WHEREAS**, under the Local Government Code of 1991, Local Government Units are mandated to generate and apply its resources for productive, developmental or welfare purposes in the exercise of furtherance of its governance or proprietary powers and functions;

**WHEREAS**, agriculture is the primary industry of the Province of Pangasinan, its agriculture sector is important for inclusive growth, being a key driver of the province's economy particularly in the rural areas where farming families live. To achieve sustainable food production, it is imperative to continuously address pressing challenges and constraints that may impact on productivity, profitability and welfare of farmers;

**WHEREAS**, to address these major concerns of the agricultural sector of our province, the Provincial Government under the leadership of Hon. Gov. Ramon V. Guico III, is implementing the Provincial Corporate Farming Project for the rice sector to increase production and increase the productivity of the farmers and make rice farming a viable and profitable enterprise congruent to the national government's self-sufficiency program;

**WHEREAS**, the Trust Fund to be utilized came from **Department of Agriculture-Agricultural Training Institute-Regional Training Center I (DA-ATI-RTC 1) in the amount of FIVE HUNDRED THOUSAND PESOS (P500,000.00)** to support the province's priority programs that could supplement the regular fund for rice development projects to be used for the implementation of the corporate farming project for rice for the crop year 2024;

**NOW, THEREFORE**, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was;


