#### **RESOLUTION NO. 1029-2024**

DECLARING MUNICIPAL ORDINANCE NO. 13, S-2023 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING THE RULES ON ADMINISTRATIVE INVESTIGATION BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF MABINI, PANGASINAN" AS WITIHN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Municipal Ordinance No. 13, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 60-68 Title Two, Chapter 4 of R.A. No. 7160";

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 13, S-2024 of the Sangguniang Bayan of Mabini, Pangasinan, entitled "An Ordinance establishing the rules on administrative investigation by the Sangguniang Bayan of the Municipality of Mabini, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
