RESOLUTION NO. 1030-2024

APPROVING RESOLUTION NO. 65, S-2024 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING RESOLUTION NO. 2, SERIES OF 2024 OF THE MUNICIPAL DEVELOPMENT COUNCIL, CALASIAO, PANGASINAN ENTITLED, "RESOLUTION ENDORSING REVISED ANNUAL INVESTMENT PROGRAM 2024 OF CALASIAO, PANGASINAN FOR CALENDAR YEAR 2024"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its SB Resolution No. 65, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Disaster Risk Reduction and Management Council of Calasiao, Pangasinan, through MDRRM Council Resolution No. 6 (Series of 2024), dated March 12, 2024, revised their MDRRM Plan, CY 2024, to utilize the Unexpended Balance of MDRRM Fund/Trust Fund (CY 2023) of the LGU, in the amount of P3,427,706.16;
2. The Municipal Development Council of Calasiao revised their AIP, CY 2024 to include new projects from the Revised MDRRM Plan of the LGU. This was endorsed by the Municipal Development Council to the Sangguniang Bayan for approval through MDC Resolution No. 2, Series of 2024 dated June 25, 2024. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;

3. The proposed projects to be funded from the MDRRM Trust Fund conform with NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund); and
4. Likewise, the preparation of the Revised AIP is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote: “The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMF”.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


