APPROVING RESOLUTION NO. 177-2024 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PLAN NO. 04 CALENDAR YEAR 2024 OF THE MUNICIPALITY OF ROSALES, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No. 177-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- The Local Development Council of Rosales, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 04 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on September 23, 2024 by the Municipal Development Council through Resolution No. 0923, S-2024. This is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991;
- 2. The Supplemental Investment Program No. 04 with a total investment requirement of PhP12,050,000.00 covers augmentation for Maintenance and Other Operating Expenses of some municipal offices and the implementation of development programs and disaster risk reduction activities in the municipality; and

3. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 04 for CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04-2024 on September 26, 2024.
