**DECLARING CITY ORDINANCE NO. 70, SERIES OF -2022-25 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING NO. 27, SERIES OF 2016-19, ENTITLED "AN ORDINANCE RECLASSIFYING A TOTAL OF FORTY-NINE THOUSAND SIX HUNDRED TEN (49,610) SQUARE METERS OF LAND AT THE FOREST LAKE MEMORIAL PARK PHASE II PROJECT IN BARANGAY PINMALUDPOD, CONVERTED BY TCT NOS. 299249, 232941, 180498, 272171, AND 232940 FROM AGRICULTURAL TO INSTITUTIONAL USE" TO "AN ORDINANCE RECLASSIFYING A TOTAL OF FORTY-NINE THOUSAND SIX HUNDRED TEN (49,610) SQUARE METERS OF LAND AT THE FOREST LAKE MEMORIAL PARK PHASE II PROJECT IN BARANGAY PINMALUDPOD, COVERED BY TCT NOS. 9966, 232941, 180498, 272171, AND 232940 FROM AGRICULTURAL TO INSTITUTIONAL USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**


