## PROVINCIAL RESOLUTION NO. 1051-2024

AMENDING PROVINCIAL RESOLUTION NO. 417-2024 ENTITLED "AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, AND THE ACTING PROVINCIAL TREASURER, CRISTY C. UBANDO, TO CREATE/OPEN AN AUTO-CREDIT PAYMENT SCHEME (ACPS) BANK ACCOUNT WITH LAND BANK OF THE PHILIPPINES FOR THE TB-DOTS FACILITY OF THE MANAOAG COMMUNITY HOSPITAL"

WHEREAS, PhilHealth Circular No. 043, S-2012 instituted the Auto-Credit Payment Scheme (ACPS) where hospitals' claims are directly credited to their designated deposit account with LANDBANK;

WHEREAS, to improve claim process efficiency, said issuance was amended through PHILHEALTH Circular No. 2017-0020 which automated PHILHEALTH's payment mechanism with the HCIs banking service providers;

WHEREAS, said Circular further prescribes standard requirements for HCI auto credit registration, official receipt information, and auto credit payment schedules;

WHEREAS, the creation/opening of an ACPS bank account with LANDBANK will be used by PhilHealth in credentialing payment for TB-DOTS patients of the Manaoag Community Hospital who have availed of TB-DOTS Package;

WHEREAS, the Sangguniang Panlalawigan previously approved Provincial Resolution No. 417-2024 which authorized the following officials and personnel of the Provincial Government of Pangasinan to sign pertinent financial documents relative to the opening of an Auto-Credit Payment Scheme (ACPS) Bank Account for the TB-DOTS Facility of the Manaoag Community Hospital with the Land Bank of the Philippines:
