#### PROVINCIAL RESOLUTION NO. 1161-2024

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE EUROLINK NETWORK INTERNATIONAL CORPORATION FOR THE RENEWAL OF THE PROVISION OF PHILHEALTH'S eCLAIMS THROUGH EUROLINK'S "EASY CLAIMS" AND "TYPE OF INTEGRATION" APPLICATION SOFTWARE

WHEREAS, Eurolink is an independent contractor and third party Electronic Claims (eCLAIMS) Health Information Technology Provider (HITP), a duly authorized, accredited and licensed by the Philippine Health Insurance Corporation (PHILHEALTH) to engage in PHILHEALTH benefit claims transactions management with LGU Pangasinan for the purpose of providing access to PHILHEALTH's eCLAIMS utility framework for the latter through Eurolink's "Easy Claims" and "Type of Integration" Application Software;

WHEREAS, PhilHealth Circular No. 2016-0016 mandates all health care facilities for the full implementation of the Electronic Claims System;

**WHEREAS**, the Province of Pangasinan has engaged the services of Eurolink Network International Corporation for the PHILHEALTH electronic claims of the fourteen (14) provincial government hospitals;

**WHEREAS**, the Memorandum of Agreement between the Province of Pangasinan and the Eurolink Network International Corporation will expire on December 31, 2024 and there is a need to renew the same;

WHEREAS, for the above purpose, there is a need for a new Memorandum of Agreement to be entered into and signed between the Province of Pangasinan, represented by Honorable Governor, Ramon V. Guico III; and the Eurolink Network International Corporation, represented by its authorized representative, Ms. Abigail Ong, Assistant Vice President for Finance, in order to substantially expedite the Philhealth claims of the Province;
