**RESOLUTION NO. 105-2025**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 4 FOR  
CALENDAR YEAR 2024 OF THE CITY OF ALAMINOS,  
PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF  
P28,710,145.11, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Supplemental Budget No. 4 for Calendar Year 2024 involving total appropriations of P28,710,145.11, which was enacted on November 05, 2024 through Appropriation Ordinance No. 2024-05, Series of 2024;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That all procurement to be taken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the city and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 2007;

3. That the utilization of appropriations from 20% Development Fund shall be in accordance with the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: “Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects”;
4. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. No. 7160 (Use of Appropriated Funds and Savings);
5. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
6. That the appropriation for Public Affairs Fund shall be spent solely for public purposes and no amount shall be applied for religious or private purposes pursuant to Sections 305(b) and 335 of R.A. No. 7160, and shall be broken down into appropriate objects of expenditures, as may be applicable, in accordance with the Revised Chart of Accounts for LGUs under COA Circular No. 2015-009 dated December 1, 2015; and
7. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF) and that 30% shall be set aside as Quick Response Fund.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the city;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 4 for Calendar Year 2024 of the City of Alaminos, Pangasinan;


