RESOLUTION NO. 106-2025

DECLARING ORDINANCE NO. 2024-37 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE AUTHORIZING THE BORROWING OF THE CITY GOVERNMENT OF ALAMINOS, PANGASINAN IN THE AGGREGATE AMOUNT OF TWO HUNDRED NINETY-TWO MILLION PESOS (P292,000,000.00) WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) TO FINANCE THE FOLLOWING PROJECTS OF THE CITY FOR THE ALAMINOS CITY COLLEGE: A. LOT ACQUISITION (PROJECT SITE) - P193,447,000.00, B. CONSTRUCTION OF SCHOOL BUILDING - P98,553,000.00" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2024-37 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

No. 7160;




