APPROVING MUNICIPAL RESOLUTION NO. 187-2024 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 03 SERIES OF 2024 OF THE MUNICIPALITY OF ANDA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 187-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Municipal Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Anda, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 03, Series of 2024. This was endorsed to the Sangguniang Bayan for approval on October 3, 2024 by the Municipal Development Council thru MDC Resolution No. 04, Series of 2024, which was favorably acted upon by the Sangguniang Bayan on November 4, 2024 thru Municipal Resolution No. 187-2024;
- 2. Said SIP covers fund augmentation for the implementation of various development programs/projects of the LGU to be funded under the LGU's loan proceeds from Land Bank of the Philippines; and

3. Funding support for the implementation of the same in the amount of PhP200,000,000.00 is embodied in their proposed Supplemental Budget No. 3 for Budget Year 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 03, Series of 2024 on November 4, 2024 and approved by the Municipal Mayor on November 11, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Anda, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Municipal Resolution No. 187-2024 of the Sangguniang Bayan of Anda, Pangasinan, entitled "Approving the Supplemental Investment Program (SIP) No. 03, Series of 2024 of the Municipality of Anda, Pangasinan";
