PROVINCIAL RESOLUTION NO. 1098-2024

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE UNIVERSITY OF THE PHILIPPINES (UP) BAGUIO RELATIVE TO THE SECONDMENT OF DR. RAYMUNDO D. ROVILLOS TO THE PANGASINAN POLYTECHNIC COLLEGE (PPC) TO SERVE AS ITS PRESIDENT

WHEREAS, the University of the Philippines is the national university created by virtue of Republic Act No. 9500, otherwise known as “An Act to Strengthen the University of the Philippines as the National University”;

WHEREAS, the Pangasinan Polytechnic College (PPC) is a public, non-sectarian, non-partisan technical-vocational, and higher educational institution operating primarily from the subsidy of the Provincial Government of Pangasinan;

WHEREAS, the PPC needs the services of a highly competent and technically proficient person who will serve as its Interim President;

WHEREAS, Dr. Raymundo D. Rovillos, a Professor at the Department of History and Philosophy, College of Social Sciences of the University of the Philippines Baguio, has been identified to qualify for the said position at PPC and has in fact been serving as Interim President of the PPC by virtue of a previously approved secondment for the period February 1, 2024 to January 31, 2025;

WHEREAS, Dr. Raymundo D. Rovillos is willing to be seconded to the PPC for the period from February 1, 2025 to January 31, 2026 and hereby accepts and agrees to perform the duties as President as stipulated in the terms of the secondment;

WHEREAS, the other terms of the secondment are already identified in the Memorandum of Agreement to be entered into and signed by the concerned parties;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, the Memorandum of Agreement shall be entered into and signed between the Pangasinan Polytechnic College, represented by Governor Ramon V. Guico III, Chair of the Governing Board, the University of the Philippines Baguio, represented by its Chancellor, Dr. Corazon L. Abansi and Dr. Raymundo D. Rovillos, Seconded Employee;

NOW, THEREFORE, on motion of Vice Governor Mark Ronald DG. Lambino, duly seconded, it was –


