RESOLUTION NO. 110-2025

APPROVING RESOLUTION NO. 193-2024 OF THE SANGGUNIANG BAYAN OF URBIZONDO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 4 FOR FISCAL YEAR 2024 OF THE MUNICIPALITY OF URBIZONDO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Urbizondo, Pangasinan submitted its Resolution No. 193-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Urbizondo, Pangasinan prepared their Supplemental Investment Program (SIP) No. 4 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 6, S-2024 dated December 11, 2024, to the Sangguniang Bayan for approval; This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱7,499,522.90, covers the augmentation of funds for Personal Services (granting of Performance-Based Bonus and Service Recognition Incentive to qualified LGU Personnel) and Maintenance and Other Operating Expenses (MOOE) of some municipal offices of the LGU, and implementation of LDRRM programs/activities, and other priority projects of the municipality; and

3. Funding for the full implementation of the Supplemental Investment Program is embodied in the LGU's Supplemental Budget No. 04 for FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 5-2024 dated December 16, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Urbiztondo, Pangasinan;


