### RESOLUTION NO. 1108-2024

#### **APPROVING RESOLUTION NO. 2024-123 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “ADOPTING THE REVISED ANNUAL INVESTMENT PROGRAM CY 2024 OF THE MUNICIPALITY OF BOLINAO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Resolution No. 2024-123 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bolinao, Pangasinan has identified items in their Revised Annual Investment Program for CY 2024. This was endorsed to the Sangguniang Bayan on August 2, 2024 through MDC Resolution No. 3, Series of 2024;
2. The AIP of LGU Bolinao was revised to integrate the proposed disaster risk reduction and management programs/projects/activities to be funded from the unexpended balances of the LGU’s LDRRM Fund CY 2019-2023 and current fund (2024-part) amounting to PhP5,758,637.81. This has emanated from the MDRRM Council through Resolution 01, Series of 2024 dated April 29, 2024. This is in pursuance to Section 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, which states: “The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission

of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP”; and

3. These disaster risk reduction and management programs are based on the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund).


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bolinao, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


