RESOLUTION NO. 111-2025

DECLARING THE SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2024 OF URBIZTONDO, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P7,499,522.90, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Supplemental Budget No. 4 for Calendar Year 2024 involving total appropriations of P7,499,522.90, which was enacted on December 16, 2024 through Appropriation Ordinance No. 5-2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the said supplemental budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;

3. That the appropriation for Performance-Based Bonus shall only be disbursed until such time that the guidelines authorizing the same is issued by proper authority;
4. That the grant of Service Recognition Incentive (SRI) for FY 2024 to all municipal officials, regular and casual employees of the municipality shall be in accordance with the provisions of Budget Circular No. 2024-7 dated December 16, 2024;
5. That the grant of Gratuity Pay for FY 2024 to Contract of Service (COS) and Job Order (JO) shall be in accordance with the provisions of Budget Circular No. 2024-8 dated December 20, 2024;
6. That the purchase of rescue boat carrier shall be in accordance with the provisions of DBM Budget Circular No. 23022-1 dated February 11, 2022 (Omnibus Guidelines on the acquisition, use, rental, and replacement of Government Motor Vehicles); and
7. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF), and that 30% shall be set aside as Quick Response Fund.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


