DECLARING MUNICIPAL ORDINANCE NO. 2024-01 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "TO CREATE PLANTILLA POSITIONS OF MEDICAL OFFICER III SG 21, MEDICAL TECHNOLOGIST II SG 15, INFORMATION SYSTEMS ANALYST II SG 16, LICENSING OFFICER II SG 15, AGRICULTURIST II SG 15, LABOR AND EMPLOYMENT OFFICER II SG 13, THREE (3) ADMINISTRATIVE AIDE III (DRIVER I) SG 3, ADMINISTRATIVE AIDE III (UTILITY WORKER II) SG 3, CONSTRUCTION AND MAINTENANCE MAN SG 2, AND TEN (10) ADMINISTRATIVE AIDE I (UTILITY WORKER I) SG I, IN THE MUNICIPALITY OF BOLINAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT




