RESOLUTION NO. 1112-2024

DECLARING MUNICIPAL ORDINANCE NO. 2024-02 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE PHILIPPINE PACKAGE OF ESSENTIAL NON-COMMUNICABLE DISEASES (NCDs) INTERVENTIONS (PHILPEN) ON THE INTEGRATED MANAGEMENT OF HYPERTENSION AND DIABETES FOR PRIMARY HEALTH CARE FACILITY IN THE MUNICIPALITY OF BOLINAO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Municipal Ordinance No. 2024-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iii), and 447 (a) (5) (xiv) of R.A. No. 7160; Section 15, Article II (Principles) and Section 11, Article XIII (Health) of the 1987 Philippine Constitution; DOH Administrative Order No. 2011-0003, entitled “National Policy on Strengthening the Prevention and Control of Chronic Lifestyle Related Non Communicable Diseases”; DOH Administrative Order No. 2012-0029, entitled “Implementing Guidelines on the Institutionalization of Philippine Package of Essential NCD Interventions (PhilPen) on the Integrated Management of Hypertension and Diabetes for Primary Health Care Facilities”; and DOH Administrative Order No. 2010-0036, entitled “The Aquino Health Agenda: Achieving Universal Health Care for All Filipinos”;


WHEREAS, the Local Chief Executive in coordination with Municipal Finance Committee shall provide an appropriation in next year's annual budget to implement the subject ordinance;


