**RESOLUTION NO. 1114-2024**

**DECLARING ORDINANCE NO. 10, S-2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED “AN ORDINANCE APPROVING THE RECLASSIFICATION FROM AGRICULTURAL ZONE TO UTILITIES, TRANSPORTATION, AND SERVICES ZONE OF LOT NOS. 4436-P, 4437, 4443, 4448, 4449, 6247, 6250, 4438-A, 4438-B, 4438-C, 4438-D, 4438-E, 5583-C, 5583-E AND 5583-F SITUATED IN BARANGAYS BATANG, BAYAMBANG AND BAMBAN, INFANTA, PANGASINAN WITH A TOTAL LAND AREA OF 807,147 SQUARE METERS FOR THE PROPOSED SOLAR FARM PROJECT OF TERA RENEWABLES 3 CORPORATION” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Infanta, Pangasinan submitted its Municipal Ordinance No. 10, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Department of Human Settlements and Urban Development have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

**WHEREAS**, the requisite of public hearing under Section 20 of the Local Government Code has been complied;

**WHEREAS**, the Municipality of Infanta has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2017-2026;

**WHEREAS**, the Sangguniang Bayan submitted its Resolution No. 140, S-2024 (Resolution Proposing the Reclassification of Some Parcels of Land in Barangays Batang, Bayambang, and Bamban, Infanta, Pangasinan and Stating That the Said Locality has Become Highly Urbanized and the Lands Will Have Greater Economic Value for Non-Agricultural Purposes);

**WHEREAS**, Clearance for Reclassification (Certifications) from the Department of Agriculture and Department of Agrarian Reform are already accomplished and submitted to the Sangguniang Panlalawigan;

**WHEREAS**, the Department of Human Settlements and Urban Development endorsed the approval of the subject ordinance since the agricultural area subject of reclassification is still within the prescribed reclassification limit of the Municipality of Infanta, Pangasinan.

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 10, Series of 2024 of the Sangguniang Bayan of Infanta, Pangasinan, entitled “An Ordinance approving the Reclassification from Agricultural Zone to Utilities, Transportation, and Services Zone of Lot Nos. 4436-P, 4437, 4443, 4448, 4449, 6247, 6250, 4438-A, 4438-B, 4438-C, 4438-D, 4438-E, 5583-C, 5583-E And 5583-F situated in Barangays Batang, Bayambang and Bamban, Infanta, Pangasinan with a total land area of 807,147 square meters for the proposed Solar Farm Project of Tera Renewables 3 Corporation” as within the conferred powers of the Sangguniang Bayan to enact;
