RESOLUTION NO. 1117-2024

DECLARING SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2024 OF LINGAYEN, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P20,018,575.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Supplemental Budget No. 02 for Calendar Year 2024 involving total appropriations of Php20,018,575.00 which was enacted on September 9, 2024 through Appropriation Ordinance No. 02, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;

3. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
4. That the items funded out of the Local Disaster Risk Reduction and Management Council-Department of the Interior and Local Government (DILG) Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF) & that 30% shall be set aside as Quick Response Fund;
5. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020; and
6. That the appropriation for the implementation of the First Tranche Salary Schedule for Local Government Personnel pursuant to Executive (EO) No. 64, S-2024 shall be subject to the provisions of Local Budget Circular No. 160 of the Department of Budget & Management August 12, 2024, specifically item 5.0 thereof.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


