#### **RESOLUTION NO. 1119-2024**

DECLARING ORDINANCE NO. 43, S-2024 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 3, SECTION 5, SECTION 6 AND SECTION 7 OF ORDINANCE NO. 21, S-2024, ENTITLED, "AN ORDINANCE CREATING THE LOCAL YOUTH DEVELOPMENT OFFICE AND THE POSITION OF YOUTH DEVELOPMENT OFFICER 1 (SG-10), DEFINING THEIR DUTIES, POWERS AND FUNCTIONS, PROVIDING FUNDS THEREOF AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Municipal Ordinance No. 43, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Human Resource Management & Development Officer, Civil Service Commission and the Local Finance Committee of the Province conducted initial review and study on said ordinance and found out that the subject ordinance was enacted in accordance with Sections 76, 78 and 447 (a) (1) & (viii) of R.A. No. 7160;

WHEREAS, the amendment is proper to conform with the respective pertinent provisions of the Local Budget Circular No. 137 (re: Index of Occupational Services, Position, Titles and Salary Grades in Local Government (IOS-LGU), CY 2021 Edition) of the Department of Budget and Management and of the 2017 Omnibus Rules on Appointments and Other Human Resource Actions, as amended, promulgated by the Civil Service Commission;
