#### **RESOLUTION NO. 112-2025**

APPROVING SB RESOLUTION NO. 163, S-2024 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02-2024 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 163, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Malasiqui, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 02, CY 2024 of the LGU. This was endorsed by the Council, through MDC Resolution No. 03-2024, Series of 2024 dated October 10, 2024, to the Sangguniang Bayan for approval; This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental AIP, which has a total investment requirement of \$\pm\$15,022,293.00, covers the implementation of infrastructure projects supportive to tobacco farmers of the municipality;

- The projects proposed to be funded from the Excise Tax Share of the LGU (FY 2022 Collection) conform with Local Budget Memorandum No. 91 dated August 29, 2024 of the Department of Budget and Management; and
- 4. Funding support for the full implementation of this Supplemental AIP is embodied in their LGU's Supplemental Budget No. 02, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 003-2024, dated November 4, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Malasiqui, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventenilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
