**DECLARING ORDINANCE NO. 07, S-2024 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “AN ORDINANCE TRANSFERRING THE FOLLOWING PLANTILLA POSITIONS TO THE DEPARTMENT WHERE THEY WERE RE-ASSIGNED AS FOLLOWS: GINA PEREYRAS (ADMINISTRATIVE AIDE III (UTILITY WORKER II) - FROM MAYOR’S OFFICE TO THE MUNICIPAL ACCOUNTING OFFICE), MA. VICTORIA ANGELES (ADMINISTRATIVE AIDE I (UTILITY WORKER I) - FROM MUNICIPAL ADMINISTRATOR’S OFFICE TO MUNICIPAL ACCOUNTING OFFICE), SHEILA BALAGSO (ADMINISTRATIVE AIDE III (UTILITY WORKER II) - FROM MUNICIPAL ADMINISTRATOR’S OFFICE TO MUNICIPAL ENGINEERING OFFICE), RAYMUND MARTIN LEGASPI (ADMINISTRATIVE AIDE I) (UTILITY WORKER I) - FROM MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE TO MUNICIPAL TREASURY OFFICE), DON ALDRIN F. 


