**RESOLUTION NO. 1124-2024**

**DECLARING ORDINANCE NO. 08, S-2024 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “AN ORDINANCE REGULATING THE USE, SALE, DISTRIBUTION AND ADVERTISEMENT OF CIGARETTES AND OTHER TOBACCO PRODUCTS, ELECTRONIC NICOTINE AND NON-NICOTINE DELIVERY SYSTEMS, HEATED TOBACCO PRODUCTS AND OTHER NOVEL TOBACCO PRODUCTS, IN CERTAIN PLACES, IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND PROVIDING FUNDS THEREFOR, TO INSTILL HEALTH CONSCIOUSNESS AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Municipal Ordinance No. 08, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 5 of the Republic Act No. 9211, or “The Tobacco Act of 2003”; Section 24 of the Republic Act No. 8749, or the “Philippine Clean Air Act of 1999”; and Sections 16 and 447 (a) (1) (iii) (3) (ii) of R.A. No. 7160;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 & 511 (a) of R.A. No. 7160;




**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 08, Series of 2024 of the Sangguniang Bayan of Calasiao, Pangasinan, entitled “An Ordinance regulating the use, sale, distribution and advertisement of cigarettes and other tobacco products, electronic nicotine and non-nicotine delivery systems, heated tobacco products and other novel tobacco products, in certain places, imposing penalties for violations thereof and providing funds therefor, to instill health consciousness and for other purposes” as within the conferred powers of the Sangguniang Bayan to enact;
