**APPROVING RESOLUTION NO. 2024-400 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2024-08, SERIES OF 2024 ENTITLED “ADOPTION OF RESOLUTION ENDORSING THE REVISED ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN, CALENDAR YEAR 2024 AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL”**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2024-400 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan proposed for the revision of their Annual Investment Program (AIP) for CY 2024 following the approval of the Revised Local Disaster Risk Reduction and Management Fund Investment (LDRRM) Plan CY 2024 by the LDRRM Council. The Revised AIP was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 2024-08, Series of 2024 dated September 10, 2024 to the Sangguniang Bayan for approval;

2. The LGU revised their AIP for CY 2024 to cover the changes/new projects in their Revised LDRRM Plan for CY 2024 to be funded from the Unexpended Balances of LDRRM Fund, CY 2023 in the amount of P2,391,879.03. This has emanated from the LDRRM Council and approved thru LDRRM Council Resolution No. 24-11, Series of 2024 dated August 7, 2024; and
3. The preparation of the Revised AIP is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote: Section 6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
