APPROVING MUNICIPAL RESOLUTION NO. 2024-198 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF ALCALA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Resolution No. 2024-198 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Alcala, Pangasinan has identified items in their Supplemental Annual Investment Program No. 2. This was endorsed to the Sangguniang Bayan for approval on August 21, 2024 by the Municipal Development Council through Resolution No. 2024-03;
- 2. The SAIP covers fund augmentation for the Personal Services (implementation of the First Tranche Salary adjustment), and augmentation of the public affairs fund of the LGU Alcala; and

3. Funding support for the full implementation of the same in the amount of Php4,341,894.61 is embodied in their Supplemental Budget No. 2 for CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-02 on September 9, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Alcala, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-
