RESOLUTION NO. 1136-2024

DECLARING SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2024 OF SAN MANUEL, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P5,211,041.11, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Supplemental Budget No. 4 for Calendar Year 2024 involving total appropriations of Php5,211,041.11 which was enacted on August 21, 2024 through Appropriation Ordinance No. 04, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject supplemental budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- That all programs, projects and activities to be implemented are in accordance with the approved CY 2024 Annual Investment Program of the municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;

- 3. That all procurements to be undertaken shall be subject to the provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
- 4. That the grant of the First Tranche salary adjustment to all municipal officials and employees shall be implemented in accordance to the issued Local Budget Circular No. 160 by the Department of Budget and Management dated August 12, 2024, specifically item 5.0 thereof;
- 5. That the appropriation for the employer (government) share in the premium contributions payment of Terminal Leave Benefits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: "Computation and Funding of Ter to the Philippine Health Insurance Corporation (PhilHealth) shall be in accordance to PhilHealth Circular Letter No. 2019-0009 dated October 25, 2019;
- 6. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R. A. No. 10121 Known as the Philippine Disaster Risk Reduction and Management Act 2010 and its IRR and the DBM-NDRRMC-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and that 30% shall be set aside as Quick Response Fund.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince, Jr. and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was–

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 4 for Calendar Year 2024 of San Manuel, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of San Manuel, Pangasinan, for its information and guidance.
