RESOLUTION NO. 1146-2024

APPROVING RESOLUTION NO. 133, S-2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE REVISED ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF INFANTA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 133, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Infanta, Pangasinan has identified items in their Revised Annual Investment Program for CY 2024. This was endorsed to the Sangguniang Bayan on June 18, 2024 through MDC Resolution No. 06, Series of 2024;
2. The AIP of LGU Infanta was revised to integrate the proposed disaster risk reduction and management programs/projects /activities to be funded from the unexpended balances of the LGU’s LDRRM Fund CY 2023 amounting to Php5,745,520.94, which has emanated from the LDRRM Council through Resolution 3, Series of 2024 dated June 14, 2024. This is in pursuance to Section 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, which states: “The unexpended balances of the LDRRMF may be released and utilized

for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.”;

3. These disaster risk reduction and management programs are based on the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);
4. Also included are new expenditure programs/projects to be funded out of the continuing appropriation (Capital Outlay) amounting to Php3,228,574.31. It is advised however, that the LGU shall prepare a supplemental budget to support the full implementation of the identified programs/projects;
5. The revised AIP also includes development programs/projects to be funded from the realigned Municipal Development Fund CY 2024 (Conduct of Community-based Management System) amounting to PhP3,824,647.52. The proposed development projects are of the same expense class; and
6. The identified development programs/projects/activities are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects).

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Infanta, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 133, S-2024 of the Sangguniang Bayan of Infanta, Pangasinan, entitled “Approving and adopting the Revised Annual Investment Program for Calendar Year 2024 of the Municipality of Infanta, Pangasinan”;
