PROVINCIAL RESOLUTION NO. 1154-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH MARIGOLD STORE TO ESTABLISH A FORMAL PARTNERSHIP IN THE PROVISION OF TEMPORARY SHELTERS FOR INDIVIDUALS DISPLACED BY DISASTER

WHEREAS, Republic Act No. 10121 mandates the implementation of pre-emptive evacuation as a critical measure to protect lives in times of disasters, requiring immediate action and cooperation between the government and the community;

WHEREAS, Section 2, Declaration of Policy (d) of the 2021 Revised Implementing Rules and Regulations of Republic Act No. 9904 underscores the need to complement the efforts of local government units in the delivery of vital services and in implementing policies, programs and ordinances for community development, while Section 8(c) thereof encourages homeowners to participate in association projects and activities;

WHEREAS, the spirit of bayanihan, or community cooperation which stresses on mutual assistance and solidarity in times of need, is deeply ingrained in Filipino culture;

WHEREAS, as part of its mandate, the Provincial Disaster Risk Reduction and Management Office (PDRRMO) is tasked to reach out to people in distress, ensure their safety and welfare specially in times of disaster, and vested with the responsibility to provide temporary shelters to displaced families;

WHEREAS, Marigold Store, with office address at A.B. Fernandez Avenue, Dagupan City, Pangasinan, and owner of a property that is structurally safe and suitable for temporary housing, has expressed willingness to allow its property to be used as temporary shelter displaced individuals or evacuees during emergencies or disasters;

WHEREAS, in full cognizance of the importance of pre-emptive evacuation, community cooperation and the government's responsibility to ensure the safety and welfare of its citizens, the Province of Pangasinan has manifested its interest in the establishment of a formal partnership with Marigold Store, subject to the terms and conditions stipulated in the Memorandum of Agreement;


WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed by and between the Province of Pangasinan, represented by Honorable Governor Ramon V. Guico III, and Marigold Store, represented by Mr. Marlo D. Novales;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Nicholi Jan Louie Q. Sison, duly seconded, it was –


