PROVINCIAL RESOLUTION NO. 1155-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE OFFICE OF CIVIL DEFENSE REGIONAL OFFICE 1 (OCDRO1) FOR THE TRANSFER OF PORTABLE GENERATOR SETS AND RIGID HULL INFLATABLE BOAT

WHEREAS, Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, an act strengthening the Philippine Risk Reduction and Management System, provides for the mechanism to sustain efforts in disaster risk and reduction management;

WHEREAS, Section 9(p) stipulates that the OCD shall "Provide advice and technical assistance and assist in mobilizing necessary resources to increase the overall capacity of LGUs, specifically the low income and in high-risk areas";

WHEREAS, the Provincial Government of Pangasinan, through the PDRRMO, is further improving its services to continuously systematize and strategize the Province's capacity to better respond and cope with the immediate aftermath of a disaster, whether it be human-induced or caused by natural hazards;

WHEREAS, during the Early Recovery Meeting in connection with the Southwest Monsoon enhanced by Super Typhoon Egay and Typhoon Falcon on August 2, 2024, the Provincial Government of Pangasinan, through the PDRRMO, identified the following equipment as the needed early recovery augmentation, to wit:

WHEREAS, OCD Memorandum No. 1017A, Series of 2023 provides for the Expanded Guidelines for the Institutionalization, Uniformity, and Harmonization of OCD Logistics management Processes that sets forth the comprehensive directives aimed at enhancing the efficiency and coherence of OCD logistics management;

WHEREAS, the OCD will transfer the above-described equipment to the Provincial Government of Pangasinan and covered with Property Transfer Report (PTR), subject to the terms and conditions set forth in the memoranda of agreement;

WHEREAS, the Provincial Disaster Risk Reduction and Management Office, one of the frontline offices of the Provincial Government of Pangasinan in the delivery of services during times of disasters, has the capacity to man with appropriate crew, operate and maintain the equipment;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed by and between the Province of Pangasinan, represented by Honorable Governor Ramon V. Guico III, and Office of Civil Defense Regional Office 1, represented by Regional Director Gregory M. Cayetano;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Nicholi Jan Louie Q. Sison, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) with the Office of Civil Defense Regional Office 1 (OCDRO1) for the transfer of Portable Generator Sets and Rigid Hull Inflatable Boat;

RESOLVED, FURTHER, that copies of this resolution be furnished to Honorable Governor Ramon V. Guico III, Province of Pangasinan, and Regional Director Gregory M. Cayetano, Office of Civil Defense Regional Office 1, for their information and guidance.
