PROVINCIAL RESOLUTION NO. 1157-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHYSICIANS FOR PEACE PHILIPPINES, INC. FOR THE USE OF ITS MOBILE PROSTHESES ORTHOSES, WHEELCHAIR, EMPOWERMENT REINTEGRATION (P.O.W.E.R.) VAN TO BE UTILIZED BY THE LINGAYEN DISTRICT HOSPITAL IN CONNECTION WITH THE ESTABLISHMENT OF THE LATTER'S PROSTHESIS CENTER

WHEREAS, the Physicians for Peace Philippines, Inc. (PFPPPI) is a registered non-stock, non-profit, non-government humanitarian Philippine Corporation recognized by Department of Health, registered with the Securities and Exchange Commission, and certified by the Philippine Council for NGO Certification throughout the Philippines;

WHEREAS, the provincial government is an active partner of the cities and municipalities in the promotion of its worthwhile plans and programs particularly in the protection of the health and well-being of the people;

WHEREAS, the Lingayen District Hospital is one of the fourteen hospitals operated by the Provincial Government of Pangasinan that caters patients coming from the different municipalities of the 2nd District of Pangasinan and other nearby localities;

WHEREAS, the Lingayen District Hospital will be establishing a Prosthesis Center for patients who require assistive device for mobility and visual impairment and intends to seek a service provider to be used during its operation for the laboratories and other services;

WHEREAS, the PFPPPI has expressed its willingness to offer its service and to lend its MOBILE Prostheses Orthoses, Wheelchair, Empowerment Reintegration (P.O.W.E.R.) van, including the equipment and accessories at no cost, provided that the operation thereof will be manned by the personnel of the Lingayen District Hospital;

WHEREAS, the roles and responsibilities of both parties are defined in the MOA, wherein the PFPPI shall provide its MOBILE P.O.W.E.R. van to the Lingayen District Hospital every two weeks, or as deemed necessary, upon the request and approval of the parties, and the LDH shall provide the transportation and other necessary fees of the said van from Manila to LDH on the scheduled activity;

WHEREAS, Section 465(vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;


WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Physicians for Peace Philippines, Inc., represented by Ms. Lyne A. Abanilla, Chief Operating Officer;

NOW, THEREFORE, on motion of SP Members Shiela Marie F. Baniqued and Jerry Agerico B. Rosario, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Physicians for Peace Philippines, Inc. for the use of its MOBILE Prostheses Orthoses, Wheelchair, Empowerment Reintegration (P.O.W.E.R.) Van to be utilized by the Lingayen District Hospital in connection with the establishment of the latter's Prosthesis Center;
