PROVINCIAL RESOLUTION NO. 1160-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH CYDEN MEDICALE TRADING, INC. FOR THE PROVISION, INSTALLATION, COMMISSIONING, OPERATION AND MAINTENANCE OF TEN (10) BRAND NEW DIALYSIS MACHINES TO BE LOCATED AT THE EASTERN PANGASINAN DISTRICT HOSPITAL

WHEREAS, the Province of Pangasinan has been tremendously embarking on new projects and programs to upgrade and rehabilitate its fourteen provincial government hospitals;

WHEREAS, the Provincial Government of Pangasinan has been offered by Cyden Medicale Trading, Inc. for the use of much-needed medical equipment which are necessary and beneficial to patients needing dialysis treatments;

WHEREAS, the Province shall, in turn, exclusively purchase from Cyden Medicale Trading, Inc. consumables necessary for the use and operation of the machines during the seven-year agreement period, subject to the terms and conditions of the MOA;

WHEREAS, the equipment could further enhance better and more accessible ways of public health and medical services to the people of Pangasinan, especially the underprivileged;

WHEREAS, Section 465 (vi) provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;


