#### **RESOLUTION NO. 1169-2024**

DECLARING MUNICIPAL ORDINANCE NO. 2024-07 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING STRAY ANIMALS FROM ROAMING OR LOITERING IN PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF AGNO, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Ordinance No. 2024-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (4) (viii) of R.A. 7160; Republic Act No. 8485 or the "The Animal Welfare Act of 1998"; and Republic Act No. 9482 or "The Anti-Rabies Act of 2007";

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
