#### **RESOLUTION NO. 1170-2024**

DECLARING MUNICIPAL ORDINANCE NO. 2024-08 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING A DRUG-FREE WORKPLACE IN THE LOCAL GOVERNMENT UNIT OF AGNO AND PROVIDING SANCTIONS FOR VIOLATION THEREOF"AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Agno, Pangasinan submitted its Ordinance No. 2024-08 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 447 (a) (1) (v) of R.A. 7160; Section 2 of R.A. 9165 also known as the "Comprehensive Dangerous Drugs Act of 2002";

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
