APPROVING RESOLUTION NO. 103-2024 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Municipal Resolution No. 103-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

- Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Burgos, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 2 CY 2024. This was endorsed to the Sangguniang Bayan on August 16, 2024 through MDC Execom Resolution No. 001, Series of 2024;
- 2. Said SAIP No. 2 covers fund augmentation for Personal Services (implementation of the First Tranche Salary Schedule for Local Government Personnel and other personnel benefits), and Maintenance and Other Operating Expenses of some municipal offices, and the implementation of various development programs/projects of the LGU; and

3. The proposed SAIP has a total investment requirement of PhP3,206,010.56. Funding support for the implementation of such is embodied in the municipality's Supplemental Budget No. 02 FY 2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02-2024 on August 20, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Burgos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 103-2024 of the Sangguniang Bayan of Burgos, Pangasinan, entitled "Approving the Supplemental Annual Investment Program No. 2 for Calendar Year 2024 of the Municipality of Burgos, Province of Pangasinan";
