RESOLUTION NO. 1177-2024

DECLARING MUNICIPAL ORDINANCE NO. 6, S-2024 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED “AN ORDINANCE REGULATING THE USE OF PLASTIC BAGS AND POLYSTYRENE FOAM IN THE MUNICIPALITY OF MABINI, PANGASINAN AND PRESCRIBING PENALTIES THEREFORE” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Ordinance No. 6, S- 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (iii) (vi) (5) (xiii) of R.A. 7160; and RA No. 11898, entitled “An Act Institutionalizing the Extended Producer Responsibility on Plastic Packaging Waste, Amending for the Purpose Republic Act No. 9003” otherwise known as the “Ecological Solid Waste Management Act of 2000;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—




