#### **RESOLUTION NO. 1178-2024**

APPROVING RESOLUTION NO. 419, S-2024 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3 CY 2024 OF BASISTA, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Resolution No. 419, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Basista, Pangasinan prepared their Supplemental Investment Program (SIP) No. 3 for CY 2024 and endorsed the same through MDC Resolution No. 4, Series of 2024 dated October 15, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental Investment Program, which has a total investment requirement of ₱2,216,269.28, covers augmentation of funds for Maintenance and other Operating Expenses and Capital Outlay of some offices of the LGU and implementation of development projects of the municipality; and

3. Funding support for the implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 3, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 4, Series of 2024 dated October 28, 2024 and approved by the Local Chief Executive on November 15, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Basista, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
