**APPROVING RESOLUTION NO. 48, S-2024 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR FY 2024 OF THE MUNICIPALITY OF BUGALLON, PROVINCE OF PANGASINAN INVOLVING THE AMOUNT OF THREE MILLION ONE HUNDRED EIGHTEEN THOUSAND SIX HUNDRED SIXTY FIVE PESOS AND EIGHTY THREE CENTAVOS (P3,118,665.83)”**

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 48, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Bugallon, Pangasinan prepared their Supplemental Investment Program (SIP) No. 2 for FY 2024. This was endorsed by the Council, through MDC Resolution No. 02, Series of 2024 dated September 20, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱3,118,665.83, covers the implementation by the LGU of the First Tranche of the Modified Salary Schedule for Local Government Personnel;


