RESOLUTION NO. 1181-2024

DECLARING SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2024 OF BUGALLON, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P3,118,665.83, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2024 involving total appropriations of P3,118,665.83, which was enacted on September 30, 2024 through Appropriation Ordinance No. 2024-02;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the implementation of the First tranche salary adjustment to all municipal officials and employees shall be in accordance with the provisions of Local Budget Circular No. 160 dated August 12, 2024 re: Implementation of the First Tranche of the Modified Salary Schedule for

Local Government Personnel pursuant to Executive Order (EO) No. 64, s. 2024, specifically item 5.0 thereof; and

3. That the reversion of savings shall be in accordance with the provisions of Section 336 of R. A. No. 7160 (Use of Appropriated Funds & savings).

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


