RESOLUTION NO. 1189-2024

DECLARING MUNICIPAL ORDINANCE NO. 2024-03 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING SUPPORT FOR EXITING AND GRADUATING PANTAWID PAMILYANG PILIPINO PROGRAM BENEFICIARIES IN THE MUNICIPALITY OF BINALONAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Ordinance No. 2024-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16 & 17 (b) (2) (iv), 447 (a) (5) (xiv) of R.A. 7160; Republic Act No. 11310, otherwise known as the “Pantawid Pamilyang Pilipino Program (4Ps) Act;

WHEREAS, the Local Chief Executive in coordination with Municipal Finance Committee shall provide an appropriation and also take into consideration the annual increase it mandates to implement the subject ordinance;


