#### **RESOLUTION NO. 1195-2024**

APPROVING RESOLUTION NO. 24-103 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2024-001 EMBODYING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1 FOR FY 2024 OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Municipal Resolution No. 24-103 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Sta. Maria, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 01 for FY 2024. This was endorsed to the Sangguniang Bayan on September 2, 2024 through MDC Resolution No. 2024-001;
- 2. The SAIP No. 01 of the municipality covers fund augmentation for Personal Services (First Trance of Salary Adjustment to all municipal officials and employees) and Maintenance and Other Operating Expense of some municipal offices and the implementation of disaster risk reduction programs of the municipality;

- 3. Likewise, SAIP No. 01 also covers the implementation of programs, projects and activities (Concreting/Rehabilitation of San Alejandro Farmto-Market Road) to be funded from the municipality's share from the FY 2021 & FY 2023 Tobacco and Burley Excise Tax. Said project is consistent with Local Budget Memorandum No. 89 dated November 10, 2023; and
- 4. Funding support for the proposed SAIP No.01, with a total investment requirement of PhP11, 619,295.60 is embodied in the municipality's Supplemental Budget No.1, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 24-03 on September 24, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta Maria, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 24-103 of the Sangguniang Bayan of Sta. Maria, Pangasinan, entitled "Approving the Municipal Development Council (MDC) Resolution No. 2024-001 embodying the Supplemental Annual Investment Program (SAIP) No. 1 for FY 2024 of the Municipality of Sta. Maria, Pangasinan";
