#### **RESOLUTION NO. 1196-2024**

DECLARING SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2024 OF STA. MARIA, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P11,619,295.60, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2024 involving total appropriations of P11,619,295.60, which was enacted on September 24, 2024 through Appropriation Ordinance No. 24-03;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the reversion of savings from the Personal Services (PS) shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

- 3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the municipality and its Supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
- 4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
- 5. That the implementation of the First tranche salary adjustment to all municipal officials and employees shall be in accordance with the provisions of Local Budget Circular No. 160 dated August 12, 2024 re: Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel pursuant to Executive Order (EO) No. 64, S. 2024, specifically item 5.0 thereof;
- 6. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R. A. No. 10121 Known as the Philippine Disaster Risk Reduction and Management Act 2010 and its IRR and the DBM-NDRRMC-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and that 30% shall be set aside as Quick Response Fund);
- 7. That the grant of increase in Representation and Transportation Allowances (RATA) shall be in accordance with the provisions of Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management;
- 8. That the appropriation for the payment of Monetization of Leave Credits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: "Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits", which provides for the new constant factor stated under Item 3.1 thereof;
- 9. That the utilization of appropriations from shares of the Municipality from Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum No. 89 dated November 10, 2023; and
- 10. That the appropriation for Service Recognition Incentive (SRI) of municipal officials and employees shall be disbursed in accordance with the circulars granting the same to be issued by proper authorities and shall be subject to Section 325(a) of R.A. No. 7160.
