APPROVING RESOLUTION NO. 417, S-2024 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 6 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) THRU RESOLUTION NO. 8, SERIES OF 2024”

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 417, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

1. The Municipal Development Council of Bayambang, Pangasinan prepared the LGU's Supplemental Annual Investment Program No. 6 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 8, Series of 2024 dated July 24, 2024 to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱2,525,372.00, covers the implementation of proposed GAD-related projects and activities under the revised GAD Plan and Budget, FY 2024 of the LGU;

3. The revised GAD Plan and Budget FY 2024 of the LGU was reviewed and approved by the DILG Provincial Office, and found to be the compliant in form and content with the provisions of PCW-DILG-DBM-NEDA Joint Memorandum Circular Nos. 2013-01 (Guidelines on the Localization of Magna Carta for Women) and 2016-01 (Amendments to PCW-DILG-DBM-NEDA Joint Memorandum Circular Nos. 2013-01: Guidelines on the Localization of Magna Carta for Women); and
4. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 06, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 6, Series of 2024 dated September 23, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


