RESOLUTION NO. 1201-2024

DECLARING ORDINANCE NO. 24-19 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING PROVINCIAL ORDINANCE NO. 317-2024, ENTITLED: "AN ORDINANCE REGULATING THE USE, SALE, DISTRIBUTION AND ADVERTISEMENT OF CIGARETTES AND OTHER TOBACCO PRODUCTS, ELECTRONIC NICOTINE AND NON-NICOTINE DELIVERY SYSTEMS, HEATED TOBACCO PRODUCTS AND OTHER NOVEL TOBACCO PRODUCTS, IN CERTAIN PLACES, IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND PROVIDING FUNDS THEREFOR, TO INSTILL HEALTH CONSCIOUSNESS AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 24-19 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted in accordance with Sections 16 & 458 (a) (1) (iii) (3) (ii) of R.A. 7160; Executive Order No. 26 entitled: "Providing for Establishments of Smoke-Free Environments in Public and Enclosed Places"; Section 24 of R.A. 8749, otherwise known as the Philippine Clean Air Act of 1999; and Section 5 (a) (b) (c) (d) (e) of RA 9211 or Tobacco Regulation Act of 2003;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 24-19 of the Sangguniang Panlungsod of San Carlos, Pangasinan, entitled "An Ordinance adopting Provincial Ordinance No. 317-2024, entitled: "An Ordinance regulating the use, sale, distribution and advertisement of cigarettes and other tobacco products, electronic nicotine and non-nicotine delivery systems, heated tobacco products and Other Novel tobacco products, in certain places, imposing penalties for violations thereof and providing funds therefor, to instill health consciousness and for other purposes" as within the conferred powers of the Sangguniang Panlungsod to enact;
