**RESOLUTION NO. 1203-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 2024-006 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “AN ORDINANCE DECLARING THE MUNICIPAL GROUNDS OF LAOAC, PANGASINAN AS PUBLIC PARK AND GREEN SPACES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Laoac, Pangasinan submitted its Ordinance No. 2024-006 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (iii) (5) (v) (vi) (6) of R. A. 7160;

**WHEREAS**, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2024-006 of the Sangguniang Bayan of Laoac, Pangasinan, entitled “An Ordinance declaring the municipal grounds of Laoac, Pangasinan as public park and green spaces” as within the conferred powers of the Sangguniang Bayan to enact;


