**DECLARING ORDINANCE NO. 2024-29 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING SECTIONS 1, 4 AND 5 OF ORDINANCE NO. 2023-24 ENTITLED “AN ORDINANCE ESTABLISHING THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO) OF THE LOCAL GOVERNMENT OF THE CITY OF ALAMINOS, PANGASINAN AND CREATING THE POSITION OF CITY ENVIRONMENT AND NATURAL RESOURCES OFFICER 1 TO HEAD THE OFFICE AND PROVIDING FUNDS THEREOF”, DULY ENACTED ON 18 JULY 2023” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2024-29 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Human Resource Management & Development Officer, Civil Service Commission and the Local Finance Committee of the Province conducted initial review and study on said ordinance and found out that the subject ordinance was enacted in accordance with Sections 76, 454 (b) (c), 458 (a) (1) (viii) of R.A. No. 7160;

**WHEREAS**, the amendments are proper and conform with the provisions of the Civil Service Commission Memorandum Circular No. 6, S-2023;


